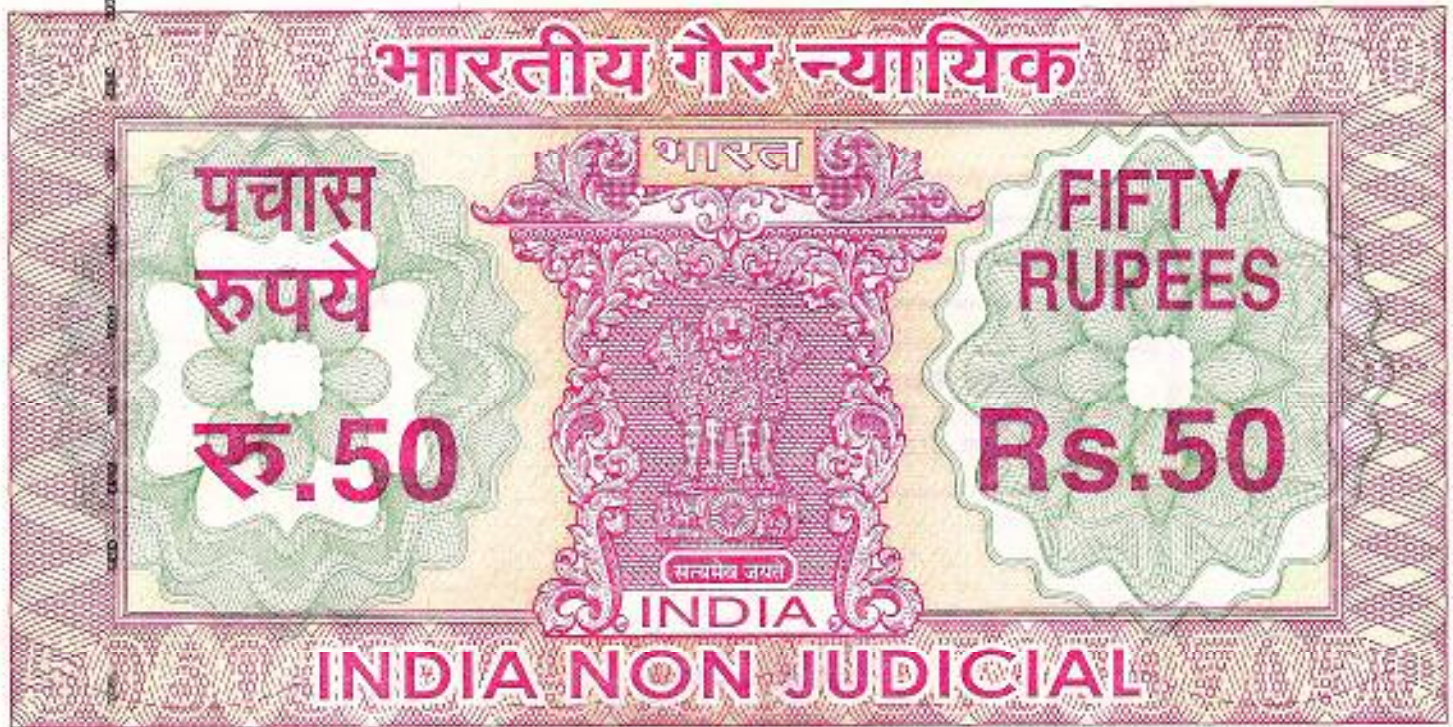

- vi) To establish, maintain, support hostel for boarding and/or lodging for the students of the educational Institutions run/ conducted by the Trust or by any other Trust, Organization, Society, Association or Institutions with similar objects.
- vii) To publish books, periodicals, journals, newsletters, bulletins etc. for advancement of education and diffusion of knowledge.
- viii) To undertake advisory, supervisory, collaborative and consultancy work of any type of project assignment for any person, public or private Trust, Institutions, Organizations, Societies, Autonomous Bodies, Company, Firm, State or Central Government anywhere in the country.
- ix) To establish, develop, maintain, and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare canters and/or such other similar charitable institutions in India for benefit and use of general public.
- x) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses for use of the public in general.
- xi) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- xii) To establish and develop Institutions for the physically handicapped and disabled or mentally retarded person and to provide them education, food, clothing or other help.
- xiii) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire pestilence etc. and to give donations and other assistance to institutions establishments or persons engaged in such relief work.
- xiv) To grant or render assistance to other public charitable trusts or institutions.
- xv) To do all other acts and things as may be necessary or conducive to the attainment of the object of the Trust.

POWER OF TRUSTEES

- (5) That for the furtherance of the objects of the Trust, the Trustees shall have the following powers.
- i) To accept any donation, contribution, grant or subscription in cash or in kind from any person, body of persons, any public or private trust, institutions, company, firm whomsoever with or without condition.
  - ii) To apply the whole or any part of the income of the Trust, or the Trust Fund or accumulation thereto, to any one or more of the objects of the Trust, as the Trustees may in their discretion, deem fit and proper from time to time.
  - iii) To convert and deal with the Trust property or any investment for the time being.
  - iv) To invest the Trust Fund either in the purpose of mortgage of immovable properties or in shares, stock or debentures or other securities and investment, or in deposit with or loan to any bank, company, firm or any other person, and to alter, vary and transpose such investment, from time to time at the discretion of the Trustees.
  - v) To borrow or raise to secure payment of money and also to lend money either with or without security or interest.
  - vi) To sell, transfer, dispose of alienate or otherwise deal with any property comprising the Trust Fund.
  - vii) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the trustees in their discretion may think fit.
  - viii) To open account in the name of the Trust, trustees or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such accounts and to give instructions to the Bank(s) and to provide for opening and operation of such accounts by Managing Trustees/Chief Executive Officer of the Trust or by more than one Trustee including Managing Trustee/ Chief Executive Officer of the Trust or by an agent appointed by the Managing Trustees.

- ix) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund and Assets.
- x) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their places.
- xi) To appoint or make provision for the appointment of Managing Trustee for the purpose of administration of the Trust in such manner and subject to such rules and regulations as the Trustees may think fit and also to designate Managing Trustee as Chief Executive Officer of the Trust.
- xii) To appoint or provide for the appointment of separate Trustee(s) to hold any Fund or investment subject to the provision of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- xiii) To appoint, engage, dismiss, suspend, terminate any official(s), employee(s) and person(s) in permanent, temporary, contractual or special service in connection with the work of the trust, Trust Estate, Trust Properties, Trust Funds or Institutions run/conducted by the Trust as the trustees may in their absolute discretion, deem fit from time to time and to determine their powers and duties and fixed their salaries, honorarium, terms of appointment and such other related things as the Trustees may think fit from time to time.
- xiv) To establish and maintain Provident Funds, Gratuity Funds, Personal and other Funds for any employee(s) in such manner and subject to such rules and regulations as the Trustees may from time to time think fit, following the Government's rules and regulations.
- xv) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for management of the affairs thereof and/or running any institution(s) in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.
- xvi) To start, abolish, discontinue and restart any charity or charitable institution for the benefit of general public and to impose any condition to any subscription or donation made by them.

- xvii) To set apart or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- xviii) To join, co-operate or amalgamate this Trust with other or others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit particularly having regard to and in conformity with the objects and nature of the Trust.
- xix) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable Institutions Societies, Organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such Institutions, Societies, Organizations or Trusts to start, maintain or carry out such charitable objects.
- xx) To settle all accounts and to compromise, compound, abandon or refer to arbitration any action or proceedings or disputes, claims, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned.
- xxi) To borrow money from bank, financial institutions, person(s), associations of persons, public or private trust, company, firm or from such other organizations either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of the presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- xxii) To obtain permission, license, approval, affiliation from the authority concerned for carrying out the objects of the trust and for the management of the affairs thereof and for running any Institutions in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.

- xxiii) To apply to the government, public bodies, urban, local municipal, districts and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the government departments, public and other bodies, corporations, companies and persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- xxiv) To take over and amalgamate with any other charitable trust, society, associations or institutions with similar objects.
- xxv) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing, organizing or maintaining any branch of the Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- xxvi) To take over, acquire, manage, control or aid any existing institution or Institutions having objects either wholly or in part similar to objects of this Trust and on such terms and conditions as may be thought expedient.
- xxvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- xxviii) To transfer all or any part of the property, assets, liabilities and engagements of the trust to any one or more of the trusts, societies, institutions or associations
- xxix) To exercise such other powers and perform such other functions as may be necessary to fulfill any or all of the objectives of this Trust or Institutions run or conducted by the Trust.
6. i) To open any sister concern about any stream of education/other matters.  
ii) To stop / abolished the Trust at any time.  
iii) To take any decision about any matters which are good for the Trust. iv) To take the nominated legal heirs of the present Trustee after their death as Trustee.

- v) The settler will be the Managing Trustee/Chief Executive Officer of the Trust.
  - vi) The Chairman of the trust and the Managing trustee of the trust shall operate the all Bank account of the Trust & The Institute jointly unless otherwise this provision may be changed by resolution duly signed by the Chairman and the Managing trustee and duly circulated to all concerned.
  - vii) To run the sister concern Trust shall create separate rules for the said particular sister concern.
  - viii) All the matters will be settled within the limitations of Kalyani jurisdiction.
  - ix) Before resignation / Expulsion the Trustee must submit all documents / Accounts / Duties in a meeting of the Trust where both the Chairman and the Managing Trustee/ Chief Executive Officer must be present.
  - x) In case of Bank loan / Other loan the personal property of the Trustees shall not attached.
  - xi) Any type of communication on behalf of the Trust or on behalf of the Institute / organization established by the Trust should be approved by the Chairman and the Managing trustee of the Trust.
7. The management and control of the property of the Trust or Institutions run/ conducted by the Trust shall be vested in the Trustees and in addition to all other power the Trustees have the power to frame bye-laws as deem necessary to fulfill the objectives of the trust . It mentioned here that the number of managing trustees shall not be more than 5 (five).
  8. The Chairman of the Trust and the Settlor shall also be a Trustee and shall act as Managing Trustee and/or Chief Executive Officer jointly shall administer the Trust and/or Institutions run/conducted by the Trust during their lifetime.

9. The number of Trustees shall not be less than two or more than five. Wherever there shall be any vacancy in the Trusteeship caused by death, resignation, removal or any other cause. The Chairman of the Trust and the Settler/Managing Trustee so long as they are alive, and after their death the next Chairman and the Managing Trustee with a resolution signed by both of them be at the liberty to appoint Trustee(s) within the number mentioned above in such terms and conditions as the trustees shall deem fit proper the trustees shall not reduce to less than two. If the number of Trustees fall below two the Trustees shall not, except for the purpose of filling any vacancy, act so long number is below the said minimum.

10. Every Trustee will be at liberty to resign by giving written notice of his/her intention to do so and said resignation shall take effect from the date of receipt of such notice by the Trust.

11. A person shall cease to be a Trustee either (i) if he without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer or (ii) if he is convicted of any criminal offence or anti-national activities and if he is found to be guilty


of any work which is against the interest of the trust or if he is found to be guilty of defalcation of trust fund or, (iii) if he is requested to resign by two-third or as near thereto as possible of the remaining Trustee including Managing Trustee.

12. The Trustees may from time to time frame rules for the conduct and regulations of the meeting of the trustees. In the absence of such regulations :

(a) Minimum two Trustees including Chairman of the Trust and the Managing Trustee shall form a quorum for a meeting of the Trustees.

(b) All matters will be decided mutually by the trustees.

(c) Resolutions passed without any meeting of the Trustees but by circulations thereof and evidenced in writing under the hands of two-third of the trustees or as near thereto as possible including Chairman of the Trust and the Managing Trustee shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.

13. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing out to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the corpus or income of the trust for any purpose not authorized by these presents.
14. In the events of difference of opinion with regard to interpretation of these presents or the rules and bye-laws of the Trust and/or Institutions run/conducted by the Trust, the opinion of the Trustees shall prevail.
15. Proper and regular books of accounts of all receipts and expenditure of the Trust shall be maintained by the Trustees.
16. The Office of the Trust may be changed by the Trustee by two-third majority.
17. It is expressly declared that no part of the Trust Fund either the corpus or the income there form shall be utilized for any object which is not a charitable purpose in law, and all provisions here of shall be constructed accordingly.
